Corruption is a type of crime associated with the use of official position for personal gain. Corruption activities are one of the main types of the shadow economy. In most cases, corruption refers to the receipt of bribes from the public by government officials for personal gain and enrichment, as well as the receipt of monetary income in violation of the law.[1] However, in general, not only government officials, but also citizens who do not work in a government organization can become participants in corruption relations and the provision of certain services in exchange for something other than bribery. From an etymological point of view, the term "corruption" comes from the Latin word "corruptio", which means "corruption, bribery". According to the authors of the legal encyclopedia, "corruption is a criminal activity expressed in the use of rights and powers granted to them by officials in the field of politics or public administration in order to obtain personal wealth.[2]

In fact, corruption is a social phenomenon, the roots of which lie in the shortcomings of the organization of the civil service and the specific psychology of civil servants. This indicates the need to take administrative-legal and organizational-managerial measures to combat corruption.

Corruption changes the content of managerial relations between a citizen and a state representative and has negative consequences for both society and the state. In addition, today, in order to ensure compliance with the requirements of the state order, public groups are formed and studied in the territory of the citizens' gathering, reports from the relevant local government bodies are heard and appropriate measures are taken; Measures to eliminate identified deficiencies, as well as support the activities of local government bodies, are being implemented effectively.[7] This indicates that public control is the main factor serving to establish social justice in society, balance, equality, mutual responsibility and accountability in the relations of the individual, society and the state.[4]

Today in our republic measures are being taken to establish the causes of crime, and exposed corrupt officials are severely punished. Domestic crimes are always strictly controlled by the state. In order to prevent the escalation of crime and the absence of corrupt officials, a number of long-term measures were implemented. They determine our strategy to fight crime. It has already been proven that it is wiser to use preventive measures, for example, to prevent crime rather than punish it. It is no coincidence that Article 2 of the Criminal Code of the Republic of Uzbekistan defines crime prevention as one of the main objectives of criminal law.
